## Important information regarding the processing of tools, consumables, supplies and raw materials being delivered to or collected from Eschmann Textures International GmbH

For delivery and/or collection, ALL goods must be insured by the carrier against loss or damage during transportation. Eschmann Textures International GmbH must be advised immediately of any special lifting requirements and must be informed about any defective transport packaging.

In addition to our General Delivery and Sales Conditions, here in particular number IV Transfer of Risk 1 to 4 and number VI Warranty 4, the following must be considered for goods trade with Eschmann Textures International GmbH:

- Tools must be delivered completely disassembled. That is; all cooling/heating lines, electronics, printing plates, insets, ejectors or similar must be disassembled by the mould-maker. Disassembly by Eschmann Textures International GmbH can only be carried out in exceptional cases subject to prior discussion, at an additional cost and at the risk of the customer. Assembled tools will be subject to completion delays over and above any quoted lead-times.
- In order to facilitate safe and efficient handling each tool should have a minimum of two (ideally four) mutually opposite DIN threaded eye bolts attached.
- In the case of tools with an overall weight exceeding 4 tons, the means of transport (lorry) for unloading by crane must be provided. In the case of unloading by crane, a max weight of 10 tons may not be exceeded without prior discussion
- The customer is obliged to indicate on the delivery notes/waybill weight, designation and packaging for delivered work pieces, tools, raw material, consumables and supplies in order to assure an unambiguous identification of the delivered goods.
- In the case of hazardous materials, the corresponding data sheets must be enclosed and legal requirements for the transport must be considered. Liability to comply with all enforceable transportation regulations rests with the carrier and is expressly not the responsibility of Eschmann Textures International GmbH
- Deliveries by Eschmann Textures International GmbH are principally executed freight unpaid and uninsured.
- The customers own packaging materials will be used for return delivery unless otherwise agreed. Any additional packing requirements may incur extra cost which will be advised by Eschmann Textures International GmbH in advance.
